As part of the HUB Program's monitoring efforts, you will be sent a HUB Certification Eligibility Affidavit in approximately 24 months. Failure to complete and submit the HUB Certification Eligibility Affidavit, and/or failure to notify us of changes affecting your company's compliance with HUB eligibility requirements, may result in the revocation of your company's certification.

We have enclosed additional information that explains the benefits of HUB certification and provides additional resources which may assist you in doing business with the State of Texas. To increase your company's potential of doing business with the state please consider registration on the State of Texas' Centralized Master Bidders List (CMBL). The CMBL is an automated search engine, which is used by the state and its contractors to identify vendors for the solicitation of goods and services.
